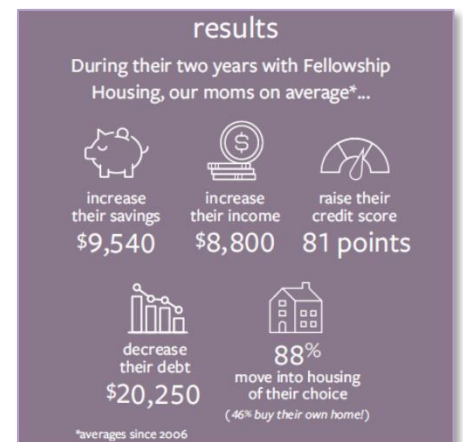
Together, we can change the trajectory of the lives of single moms and their children.
